Cllr. P. Cuddihy issued an appeal to motorists, cyclists and pedestrians in County Kilkenny to be safe on our roads over the forthcoming bank holiday weekend. (i) N76/N77 - Bridge Rehabilitation Works - Section 85 Agreement with Kildare County Council

Mr. John Mulholland advised members that Kildare County Council on behalf of other local authorities will procure and appoint a contractor for the completion of various remedial works which have been identified for bridges on the N76 and N77 in the interest of efficiency. It was Proposed by Cllr. T. Maher, Seconded by Cllr. C. Connery and agreed that "We the members of Kilkenny County Council, hereby resolve to enter into a Section 85 Agreement with Kildare County Council for the N76/N77 Bridge Rehabilitation Works whereby Kildare County Council will procure, appoint a contractor and oversee a contract for the rehabilitation of structures."

(ii) Approval of Amenity Grants 2012

Report and schedule outlining proposed allocation of amenity grants has been circulated with the agenda. Queries were raised by Cllr's M.H Cavanagh, S. Treacy, M. Doran, P. Dunphy, Ml. O'Brien, M. Shortall, T. Breathnach, P. Crowley and T. Maher.

The issues raised were as follows:-

- Critieria for assessing applications
- Funds available for unfinished estates
- Inclusion of Insurance Premium
- Unspent funds to be re-allocated to a number of groups who were previously unaware of amenity grants scheme.

Mr. Simon Walton responded to all queries raised and advised that the size of the area to be maintained determined the amount of grant allocated to estates. The issue of insurance will be discussed at the relevant SPC. It is hoped that the available budget of €50,000 has been allocated in a fair and equitable manner.

Cllr's. P. Crowley and T. Maher asked if this grant scheme was available for the provision of toilets in Kells as the lack of these facilities prevents touring buses from visiting Kells.

Mr. Mulholland advised that the current amenity grant scheme is not envisaged for these types of work. This matter should be discussed at the local area meeting.

It was proposed by Cllr. M. H Cavanagh, Seconded by Cllr. S. Treacy and agreed "That Kilkenny County Council approves the payment of Amenity Grants 2012 in accordance with the list circulated to members."

(iii) <u>Approval to initiate proceedings for the taking in charge of Estuary Woods, Ferrybank, Co. Kilkenny in accordance with Section 180 of the Planning and Development Act 2000.</u>

Cllr. T. Breathnach requested further detail in relation to why 85% of bond was accepted, transfer of open space to the local authority and completion of CCTV.

Ms. A.M. Walsh advised the meeting that following negotiations with the Bond holder in England over a prolonged period that the Council agreed to accept 85% of the Bond amount. Kilkenny County Council carried out all remedial works and has also arranged for the provision of CCTV. The transfer of open space would require substantial legal fees as the developer was in liquidation.

It was Proposed by Cllr. F. Doherty, Seconded by Cllr. T. Breathnach and agreed that "We the members of Kilkenny County Council approve the initiation of proceedings for the taking in charge of Estuary Woods, Ferrybank, Co. Kilkenny in accordance with Section 180 of the Planning and Development Act 2000."

(iv) Approval to initiate proceedings for the taking in charge of Maudlin Court (House no's 1-23) Thomastown, Co. Kilkenny in accordance with Section 180 of the Planning and Development Act 2000.

Cllr. J. Galway welcomed the taking in charge of the 23 house development at Maudlin Court, Thomastown, Co. Kilkenny and requested a commitment to the provision of speed ramps.

Cllr. Ml. O'Brien and Cllr. S. Treacy supported this as there are safety issues that need to be addressed on this access road.

Mr. J. Mulholland advised that a commitment has been given by the Area Engineer to include the provision of ramps in future road improvement programme. All funds for 2012 have been allocated to other road works.

It was proposed by Cllr. J. Galway, Seconded by Cllr. Ml. O'Brien and agreed that "We the members of Kilkenny County Council approve the initiation of proceedings for the taking in charge of Maudlin Court (House no's 1-23), Thomastown, Co. Kilkenny in accordance with Section 180 of the Planning and Development Act 2000."

(i) <u>Presentation re: National Fire Directorate Consultation</u> <u>Paper on 'Keeping Communities Safe'</u>

Mr. Joe Crockett, County Manager advised that a Consultation Paper from National Fire Directorate on "Keeping Communities Safe" has been issued. The document contains details on the following:-

- Fire Service information and trends
- Roles the range of services
- Structures to deliver the service
- National and Local priorities and targets
- Fire safety
- Fire service response
- Inter agency response to large scale incidents
- National standards
- Guidance on Fire service response
- Performance monitoring

Cllr. J. Coonan asked if there are proposals to amalgamate services. The County Manager advised that there is already interagency cooperation and sharing services will be considered.

(ii) <u>Update on 'The Gathering 2013' Initiative</u>

A detailed document outlining the background to this initiative was circulated. It gives details about what visitors can expect from the 'Gathering Ireland 2013', the benefits for the tourists and the Irish people. Facebook page and website have already been launched and major events have been announced for the year long celebration. There is a target audience of 325,000 overseas visitors and €170m tourism revenue. Document circulated is for members information.

(iii) Standing Orders

Cllr. T. Breathnach requested a number of minor changes to be made to the draft standing orders circulated. Details of changes were outlined. Cllr. A.M Irish asked could all meetings be scheduled for Mondays only. Cllr. Dunphy supported this as a number of members need to arrange meetings around their own work commitments.

Cllr. P. Cuddihy asked members to consider this request. It was agreed to defer approving the draft standing orders to the next meeting to allow members time for further consideration.

(iv) Appointment of Chairperson to SPC 2 (Transportation and Infrastructure)

It was Proposed by Cllr. E. Aylward, Seconded by Cllr. M.H Cavanagh and agreed that "Cllr. M. Doran be appointed to Chairperson on SPC 2 – Road Transportation and Infrastructure. All members agreed with the proposal.

Cllr. P. Cuddihy thanks Cllr. P. Millea for his contribution to the SPC 2 and CPG over the last few years.

Cllr's M.H Kavanagh, E. Aylward and F. Doherty thanked Cllr. P. Millea for his work on SPC 2. The County Manager thanked Cllr. Millea also.

Cllr. P. Millea thanked the County Manager and staff and members who helped him while he was Chair of the SPC.

(e) <u>Planning - Pléanail</u>

(i) <u>Update on Development Plans 2014-2020/Launch of ourplan.kilkenny</u>

Mr. Denis Malone, Senior Planner demonstrated the new ourplan.kilkenny.ie website. This allows the public to be kept informed with the process of making new County and City Development Plans for the period 2014-2020. Any member of the public can register on the site for updates as they become available. There is a submission option available on the website. Details of public meetings are also available.

Cllr. P. Cuddihy, Cathaoirleach was invited to launch the 'ourplan.kilkenny.ie' website. Denis Malone showed how to access and register on the site and gave examples of information currently available on it.

(ii) Presentation by Eirgrid re: Grid Link Project that launched on the 12th April, 2012

Cllr. P. Cuddihy welcomed James Mahony, John Lowry and Michael Donnelly of Eirgrid to the meeting. The information brochure on the Grid Link Project was circulated to all members.

Powerpoint presentation was made on the Grid Link Project. It outlined details of the transmission grid, benefits to Kilkenny, the proposed project programme and the study area and the constraints. They advised that this is a major strategic infrastructure which will be submitted to An Bord Pleanala for approval. 4 information offices are currently open and there are 7 open days for the public to get information.

Contributions were received from Cllr's J. Brennan, T. Breathnach, S. Treacy, M. Doran, P. Dunphy, C. Connery, M. Brett, M. Noonan, M.H Cavanagh, F. Doherty, M. Shortall and E. Aylward.

The issues raised by members were as follows:-

- Installation of overhead lines as against underground cables
- Cost for underground cables
- Health issues
- Is this a replacement of existing 110KV lines?
- Consultation with land owners and public
- Preferred route identification
- Further consultation when corridor routes have been identified
- Further discussion with elected members at electoral area meetings

Mr. Lowry and Mr. Mahony responded to all queries raised and stated that they are willing to meet elected members at the various stages of the project. This project will take approx. 8 to 10 years before it is completed. They assured members that there are no health issues, the electricity infrastructure is safe, there are electro-magnetic fields all around us in everyday life. The placing of cables underground is a technically inferior solution and is more costly. Long term maintenance is also an issue for underground cables in identifying where the problem is.

Discussions will be held at the appropriate time with affected landowners. It is normally wayleaves are acquired, but there is the option of CPO through the parent company E.S.B. The provision of this infrastructure will create employment in the area.

Cllr. P. Cuddihy thanked Eirgrid for their presentation.

Cllr. Cavanagh requested the member to pass this resolution in the interests of the entire country. She stated that the Treaty will be good for Ireland, and will give us access to emergency funding. She urged people to vote 'Yes'.

Cllr. M. Noonan spoke against ratifying the Treaty as it failed to recognise the wider crisis and we will lose control over our budgets.

Cllr. T. Breathnach urged that the public seriously consider their decision and noted that everyone has a right to their opinion and it should be respected.
