Notice is hereby given, that at a meeting of the Council to be held after the expiration of 10 days from the date of this notice, it is the intention of Kilkenny County Council, in accordance with Section 183 of the Local Government Act, 2001, to dispose of its interest, in Property at Barrack Street, Goresbridge, Co. Kilkenny - as identified on the attached map - to Respond having its registered office at Dominick Place, Airmount, Waterford for the nominal sum of €1,651.00 with each party being responsible for their own legal costs associated with the transfer. The Consent of the Minister for Housing, Local Government and Heritage is not required.

### **Background**

Kilkenny County Council acquired this site in 1994 and agreed to transfer the plot to Respond for a nominal fee and advance Respond loan funding for the construction 13 units of accommodation. Due to lost deed and the passing of subsequent beneficial owners, it took quite some time for the entire site to be registered to Kilkenny County Council. This was finalised in July 2014.

Kilkenny County Council has now been contacted by Respond who wish regularise matters and proceed with the transfer as originally agreed. The nominal sum for the site is paid and balance outstanding on the loan is €70,182.95 as at 31<sup>st</sup> October 2023. The loan, due to expire on 1<sup>st</sup> December 2025, will be registered as a charge on the property.

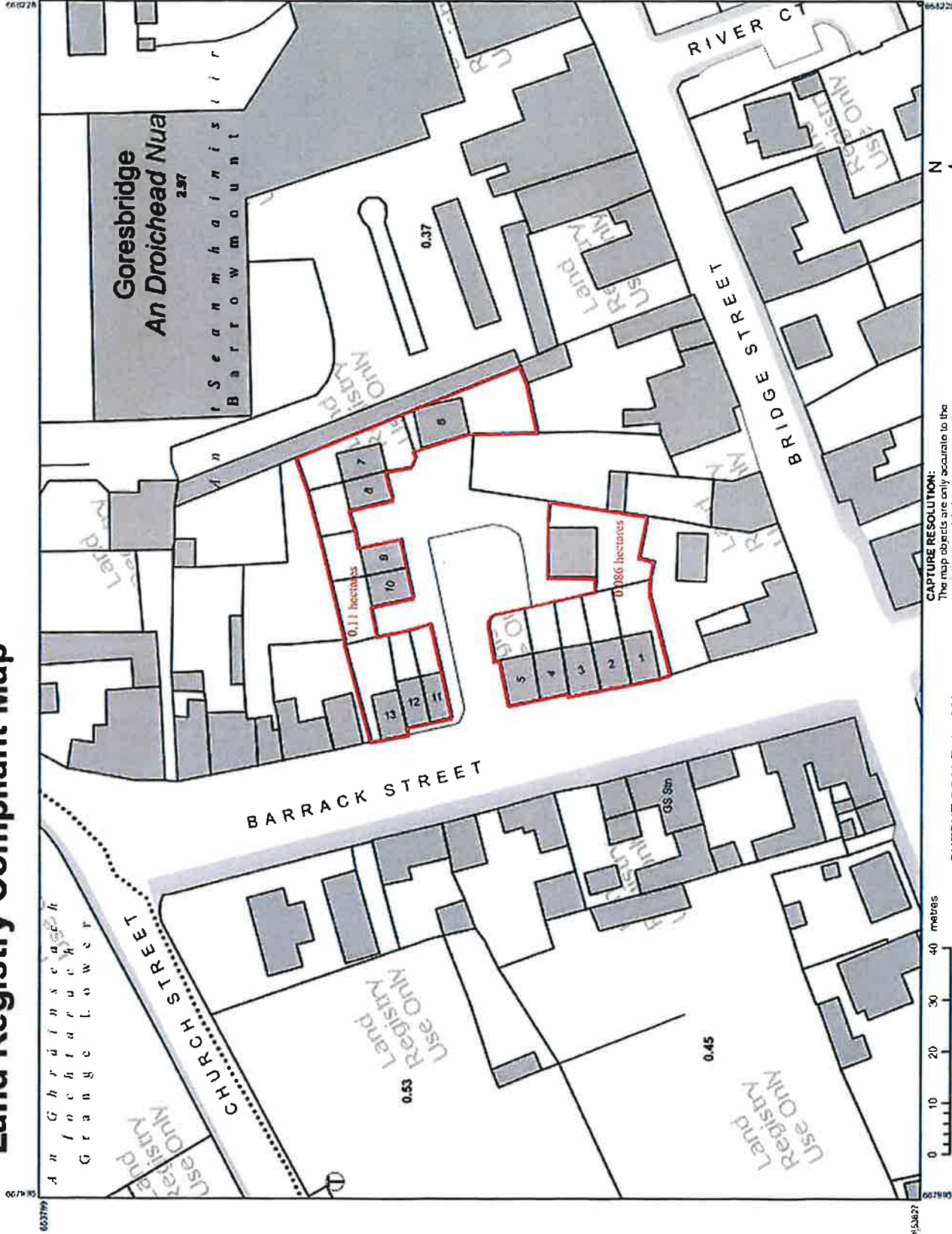
